



Admission, registration and grants

Admission requirements

To access officially Postgraduate studies, applicants must hold an official Spanish University Degree, or of any other kind awarded by an Institution of Higher Education belonging to the European Higher Education Area (EHEA), providing, within the specific country, a level of academic training equivalent to the official Spanish University Qualifications.

Students with official university degrees from countries outside the EHEA are to present a document from their university of origin assuring that the studies completed qualify one for postgraduate education. Access via this channel shall not imply, in any case, the homologation of the degree, nor its recognition for other purposes than that of taking the Postgraduate studies.

Before pre-registering, students must make sure they meet access requirements and the specific admission for the program as well as possessing the necessary documentation.

Students should consult the UIMP's web page for the procedure and the pre-registration period established for each program.

The admission of candidates is decided by the Academic Commission of each study program.

General admission criteria

Holding the preferred degree; average grade in academic transcripts; participation in other training programs; mobility during degree studies, and professional experience in subjects related to the study program.

See specific admission criteria in each program.

Minimum number of students enrolled and regulations concerning continuing presence

The number of students enrolled in each Postgraduate study cannot be less than ten (10), so that the Postgraduate study in which enrolment is below that number will be cancelled.

The UIMP has established regulations concerning continuing presence in all Postgraduate studies with a limit of examination sittings and a maximum number of years of continuing presence.

Admission applications

Admission applications for Official University Master's Degree Programs and University-Accredited Studies are filed on the "on-line pre-sign up" website, which can be found at: http://www.uimp.es/actividades-academicas/postgrado-e-investigacion.html

The admission application shall be nullified by the Admission Office if it has not received the original and/or certified documentation required by the indicated deadlines, or if the information provided does not coincide with the documents presented.

Enrolment Documentation

The academic documents of foreign degrees are to be presented translated into Spanish, where necessary; all those corresponding to countries not belonging to the EHEA are to be certified (on the UIMP's website, general information on these requirements can be found).

Doctoral Studies

The application for admission and enrollment in doctoral programs is ruled by its own regulation which should be consulted in every program.

UIMP Grants

UIMP offers grants for students admitted to university Master's programs according to academic merit.
